

TERMS OF USE

1. NO SEX TRAFFICKING; NO SOLICITATION OF PERSONAL CONTACT WITH CUSTOMERS

It is illegal and strictly prohibited for you to engage in, participate in, assist, support, or facilitate any act of prostitution, sex trafficking of children, or sex trafficking by force, fraud, or coercion. This includes, without limitation, that you are prohibited from exchanging personal contact information with any user or taking action to arrange any face-to-face meeting with a user. Also, it is prohibited for you to discuss any transaction involving any other service or product with a user, including but not limited to any other Internet-based service. Accounts found to be involved in any of these activities will be terminated, and payments will be withheld.

2. AGE DOCUMENTS MUST BE SUBMITTED FOR ALL PERFORMERS/STUDIOS

By appearing live, you are verifying that you have reached the age of 18 (19 in Canada) and have submitted all proper documentation and age verification forms to perform on the website. Only individuals who have submitted appropriate documentation and have been approved to perform may appear on cam.

3. NO BELOW-THE-WAIST NUDITY IN FREE CHAT

To prevent minors' exposure to below-the-waist nudity and adult material, no below-the-waist nudity is allowed in "free chat." Below the waist, nudity is only permitted in age-verified areas, also known as "private" or "paid chat." Below-the-waist nudity in free areas will result in temporary suspension or permanent closing of your account.

4. NO VIOLATION OF LAWS REGARDING OBSCENITY OR MINORS

Performer/Studio shall not violate any local community standard of "obscenity" during any performance related to this Agreement, including but not limited to Performer/Studio shall not depict or describe any act of a sexual nature involving bestiality, necrophilia, coprophilia, urine, faeces, vomit, blood, or others. Additionally, during any performance related to this Agreement, Performer/Studio shall not depict or describe any minor activity or act of a sexual nature involving persons under the age of 18 years (including but not limited to sex of any kind, simulated sex, sexual conduct, masturbation, bondage, domination, sadomasochism, or others).

5. NO DISCRIMINATORY OR RACIST LANGUAGE OR BEHAVIOUR

Any form of discrimination, including but not limited to comments made about Race, Sexual Orientation or Gender, is strictly prohibited and will be dealt with most seriously by The Company.

6. NO PROMOTION OF OTHER SITES

Promotion of any non-Babecall-related website directly to Babecall and affiliate site members is strictly prohibited. This includes but is not limited to chat, text, or by any other means. This includes promoting all accounts relating to social media and similar cam sites not owned and managed by Babecall. Violation of this condition will result in the termination of this Agreement and the permanent termination of your account. Babecall reserves the right to withhold payments to you if this condition is violated.

7. NOT UNDER THE INFLUENCE OF ALCOHOL OR ILLEGAL DRUGS

While giving any performance or taking any other action related to this Agreement, Performer/Studio shall not be under the influence of alcohol or any illegal drug or controlled substance.

8. NO ANIMALS OR FIREARMS ON CAM

While giving any performance, the Performer/Studio is prohibited from having any animal appear on stream and from having any firearm or gun of any type appear on stream.

9. NO FRAUDULENT ACTIVITY

While giving any performance or taking any other action related to this Agreement, the Performer/Studio shall not engage in any fraudulent activity. Fraudulent activity is any activity on the site that results in complaints or chargebacks or is deemed inappropriate by Babecall's representatives. Babecall reserves the right to terminate any account at any time for any reason if fraud is suspected and not to make any related payments.

10. IMAGE APPROVAL

Images submitted to Babecall for Performer/Studio's bio must be approved by Babecall. Images graphic in nature or containing "below-the-waist nudity" will not be approved. Babecall reserves the right to approve or reject any image submitted.

11. NON-COMPETITION

Babecall agrees that Performer can own and operate a personal website. The Performer agrees not to solicit customers and/or other Performers through their personal website that is or may be in direct or indirect competition with Babecall. Performer further agrees not to release any email addresses or web page addresses to anyone without the explicit approval of Babecall.

12. MODEL HARASSMENT

Babecall does not condone model-to-model harassment. If you are found to be harassing, bothering, teasing, distracting and/or mocking other models (either as a model or a member),

your account may be suspended or terminated. Babecall supports all models and wants everyone to succeed. We expect all models to behave maturely and support each other.

13. ACCOUNT TERMINATION

We reserve the right to terminate an account if any contractual clauses are breached, along with any terms highlighted here.

14. FALSE ADVERTISEMENT

Any girl found to be falsely advertising a service will be in breach of these terms of use. These include but are not limited to; 'Having the vibratory option enabled for customers with the toy not in use. We monitor our streams regularly, and should you be found to be falsely advertising a service, we may:

- A. First Strike: A warning
- B. Second Strike: 1 Month Suspension from using the vibratoy feature
- C. Third Strike: Removal from the vibratoy service indefinitely.

15. RULE AMENDMENTS

We reserve the right to add or amend any rule/guideline as necessary.

RULES AND REGULATIONS

As of 15th October 2021, new regulations introduced by Mastercard came into force, requiring all businesses working within the adult sector to follow the rules highlighted below.

Your line manager should have informed you of these rules and your role in complying with them. If anything is unclear, please get in touch with your line manager immediately. Failure to follow the below rules puts the business at risk of being non-compliant with Mastercard's regulations.

As an overview, merchants that engage in the provision of adult content and services will be required to:

1. If you have created an account with the company, registered your ID, and confirmed your age, you must only go live and appear in your stream. If you appear with another performer, that Performer must be age-verified and ID-checked via the same system. You must also email support@babestationcams.com to verify this.
2. Each time you log in to broadcast via cam, an ID check will be done using face recognition and compared to your Identification stored. You, the model, must log in and click to accept any consent the company needs to process your personal information.

3. Because our content is live, monitoring will be carried out by trained compliance monitoring teams to ensure that we are complying with regulations.

4. It is vital that:

- a. No one other than those who have been ID checked and age verified appears in your stream.
- b. No minors can be seen or heard in your stream
- c. No sex trafficking is permitted. The company requires ID and age verification for each model. Suppose you suspect sex trafficking may be happening or you are the victim of sex trafficking. In that case, you must inform a line manager immediately.
